1. APPOINTMENT AS SCRUTINIZER

- I. I, AMAR GOPAL GAMBHIR, Practicing Company Secretary (Membership No FCS 3668, CP No:3653), Proprietor of AGG & ASSOCIATES, Company Secretaries having office at 21/16, 2nd floor, West Patel Nagar, New Delhi- 110008 was appointed as the Scrutinizer by:
- a. The Board of the Directors of U P HOTELS LIMITED (herein after referred to as the "Company") for the purpose of scrutinizing the Remote e-voting process under the provision of section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 and
- b. By the Chairman of the AGM on poll under the provisions of Section 109 of the Companies Act, 2013 read with Rule 21 of Companies (Management & Administration) Rules, 2014 on the resolutions contained in the Notice to the Board Meeting of the Company held on 20th day of February, 2017 at PHD House, Opposite Asian Games Village, New Delhi-110016.

- II. The compliance with the requirements of the Companies Act, 2013 Act and Rules made thereunder relating to voting through electronic means(by remote e-voting) and voting by poll by the shareholders on the resolutions proposed in the Notice to the 54th Annual General Meeting of the Company is responsibility of management. My responsibility as a scrutinizer is to ensure that the voting process both through electronic means and by poll, at the meeting are conducted in a fair and transparent manner and render consolidated Scrutinizer's Report of the votes cast "in favour" or "against" if any, to the Chairman on the resolutions, based on the reports generated from the electronic voting system provided by National Securities Depository Limited (NSDL), to provide e-voting facilities for Remote e-voting and Skyline Financial Services Pvt. Ltd., the Registrar and Transfer Agents of the Company at the time of poll at AGM.
- III. The company has not complied with the Minimum Public Shareholding requirement as per Securities & Exchange Board of India (SEBI) Order No. WTM/PS/08/CFD/JUNE/2013 dated 04.06.2013. As per this SEBI Order, the Promoters shareholding has been taken as three times the shareholding of the general public for E-voting at NSDL and Poll at Annual General Meeting and the same has been shown separately in the e-voting and poll. The Shareholding Pattern of the Company for the year under review is as under:
 - Promoter & Promoter Group (4772960 Equity Shares of Rs. 10 Each) -A
 - Public-Others (627040 Equity Shares of Rs.10 Each) -B
 - Total (5400000 Equity Shares of Rs. 10 Each) -C
 - Promoters Equity as per SEBI Order 1881120 -D
 Percentage of Promoters Equity as per SEBI Order [(D/A*100)=%] (1881120/4772960*100) = 39.41%

2. CUT-OFF DATE

The company has not closed its register of members for the year under review but the cutoff date has been fixed as 25th September 2015.

3. REMOTE E-VOTING

Remote e-voting platform remained open from 15th March, 2017 at 9.30 A.M. (IST) to 17th March, 2017 at 5.00 P.M. (IST) and members were given an option to cast their vote electronically conveying their assent or dissent in respect of the Ordinary and/or Special Resolution, on the e-voting platform provided by NSDL.

4. VOTING AT THE AGM

- **4.1** After the time fixed for closing of the poll by the Chairman, ballot boxes kept for polling were locked in my presence.
- **4.2** The locked ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The polling papers were reconciled with the records maintained by the Skyline Financial Services Pvt. Ltd., the Registrar and Transfer Agent of the Company.
- **4.3** The poll papers, which were incomplete and which were otherwise found defective have been treated as invalid and kept separately.





4.4 The votes cast under remote e-voting facility were thereafter unblocked in the presence of two witnesses Ms. Rupal Gambhir and Ms. Kumari Anugaya who were not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.




