

This Addendum ("Addendum") amends and forms part of the Master Merchant Alliance Enrolment Form and Standard Terms and Conditions – Merchant Services together with the applicable schedule(s) entered into on 6th August 2018 between Sarovar Hotels Pvt. Ltd. and Mastercard Loyalty Solutions India Private Limited, f/k/a Pinpoint India Private Limited ("Mastercard") ("Agreement").

Company and Mastercard are individually referred to as "Party" and together as "Parties". Terms defined in the Agreement have the same meaning ascribed to them in the Agreement, when used in this Addendum.

Unless the context otherwise requires, the capitalised terms referred to in this Addendum and not otherwise defined herein shall have the meaning set out in the Agreement.

Save as otherwise expressly provided in this Addendum, all other terms and conditions of the Agreement shall remain unchanged, and in full force and effect.

This Addendum may be executed in counterparts, both of which shall constitute one and the same instrument.
